The Aseres Hadibros, The Ten Commandments, were written on two tablets – one comprised the laws between man and Hashem and the other between man and man. The writing engraved on each occupied the same space. The first five laws, those between man and Hashem, contain more words and therefore, presumably, were written smaller. Those between man and man were written larger. From a distance, the words that stood out clearer were those between man and man - the

interpersonal laws. I am not saying these are more or less important, but perhaps they need to be larger in our minds as they are often more easily forgotten.

At this time of year we acknowledge more than ever Hashem as the King over everything. We work on ourselves to do teshuva to eliminate the core reasons we do the wrongs we do; analysing what it is that makes us greedy, envious, arrogant, lazy, rude, or whatever flaw we have so that we can be cleansed and born anew. We ask G-d for mercy and forgiveness and we do the same with our fellow Jews. As the verse in Mishlei (27:19) says, "As water reflects the face, so does one man's heart to another," meaning just as water reflects the exact image when we look into it, so too what is in our hearts; if we show hatred or disdain to others, they will show the same back to us. If we show love, appreciation, gratitude, etc., others will show us the the same traits back - and then we're one step closer to the final redemption.

The issue of the magazine at this time of year always sees everyone working at double capacity (at least!). The JL team has excelled this year and I am very grateful to Robert, my wife Liz, and to Linda, Chandrea, and Rizelle for their outstanding work, as well as to the many superb contributors who have helped create this special edition.
